A significant purpose of the fund is to provide a member service to our clubs in the form of short-term emergency loans.

Report has been sent to the membership prior to the AGM where a more detailed run through will be provided. \$180,209 net income for the Fiscal year putting Curl BC in a healthy financial situation. This is mainly due to Federal Government subsidies which will continue into the fall

The first 2 months have been expense heavy with no events or programs able to run at this time due to COVID.

The committee met with the Stick Committee to discuss rules and next season's schedule.

Will Sutton shared a document outlining all events in the 2021-22 season which is available on our website.

Curling I/O will be used for event registrations for the 2021/22 season.

A new process has been created to facilitate people sharing any proposed rule changes or new rules to the committee. An online form can be completed for review by the committee. Anything received by July 15th will be considered for the 2021-22 season.

10. Philanthropy

The family of North Shore curler Mo MacLeod, identified the Curling for Life Endowment Fund to receive donations in memory of her.

Summary of donated membership fees processed through Curl BC's two BC Amateur Sport Fund projects.

We are currently helping process donated membership fees. 5 clubs have used this process for a total of \$55,000 from 350 curlers. 5 new clubs have set up their own funds and there are 10 active club projects.
