



PARTICIPANTS' AGREEMENT

By submitting an entry to participate in a Curl BC sanctioned competition, I hereby agree with the following:

1. I am signifying my commitment, if successful, to continue to each succeeding level of playdowns. *Refer to Rule 4. Playdown Eligibility*
2. I acknowledge that I have read and agree to adhere by the "CC Rules of Curling for Officiated Play" and the Curl BC Rules.
 - a) The rules apply from the time I leave home to attend the event until the time I return home following the event.
 - b) I understand that the curling **CODE OF ETHICS** set out at the beginning of the "CC Rules of Curling for Officiated Play" is an integral part of the sport of curling, and I agree to abide by that code.
 - c) I agree to follow the **Curl BC Athlete/Coach Code of Conduct** and will be subject to the stated penalty should inappropriate behavior occur.
 - d) I will abide by the World Curling Federation (WCF) and Canadian Centre for Ethics in Sports (CCES) Anti-doping Programs which require the avoidance of banned substances.
 - e) I will submit to random doping control testing by the Association or other authority designated to do so.
 - f) I will participate in any education sessions on Anti-doping programs as required by the association.
3. I agree to comply with all the rules and regulations respecting advertising, promotion and dress codes, established by Curl BC and its sponsors and communicated to me through the rules and the guidelines for competitors.
4. I agree to allow my name to stand on the Curl BC database (Privacy Act information available upon request).
5. I consent to Curl BC and their agent or appointees :
 - a) Photographing
 - b) Video Taping
 - c) Filming or voice recording
 - d) Publishing, and broadcasting my name and / or any photographs, video tapes, films, or any other likeness of me in any promotion, reports or advertising about or in connection with Curl BC or CC, if I am successful in winning the British Columbia Provincial Curling Championships, in any of the events leading up to and including the National Championships.
6. I hereby waive the right to any payments or royalties in connection with the actions described in subparagraphs 5 (a), (b), (c) and (d) above and in connection with any publications or broadcast, regardless of whether such exhibition, publication or broadcast is on a commercial basis and regardless of whether a fee or rental is charged or paid to anyone in connection with such publications or broadcast.
7. For the purpose of promoting the sport of curling during any telecast relating to the event, I consent to:
 - a) being interviewed at the event, and
 - b) wearing upon request of Curl BC, a portable microphone during the competition.
8. I agree that if Curl BC provides a certified coach or team manager to accompany my team to a provincial or national event with the intent of enhancing my team's performance, I will comply with the instructions of the appointee. I understand that this appointment will be done with input from my team. This includes providing the appointee with all team information, such as plans and schedules, prior to each event.
9. I, for myself, my heirs, executors, administrators, and assigns, release Curl BC and/or CC, its employees, agents and local organizers from any claim, damages, actions or causes of actions arising out of any loss, injury or damage to any person or property incurred while traveling to or from or attending at the event, notwithstanding any such loss, injury or damage which may have arisen by reason of negligence of Curl BC or CC, its employees, agents or local organizers. I further release any recourse which I may now or hereafter have resulting from any decision taken by Curl BC or CC.
10. If one or more athletes is under the age of 19 and playing in an adult category (Mixed, MD, Men's, Women's) and they do not have a coach listed, they must either appoint a coach or a chaperone. This person must have a criminal record check done if they are someone other than the parent/legal guardian of the youth or youths.
