Curl BC Zone and Region Structure BYLAW CHANGE – Core Proposal

BACKGROUND to the Core Proposal

Geographical Areas

31 January 2021

Currently, Curl BC regions are not synchronized with provincial sub-area (zone) boundaries of other sport organizations in BC. This fact has negative impacts to both general administration of curling and management of competitions. During 2019 and 2020, the Curl BC Board assessed the situation and committed to putting forth bylaw changes that would facilitate alignment and improve the zone-region structure for curling in BC.

Considering the geographical changes has led the Curl BC Board to also review how the organization's governance model is structured relative to the regions of BC. Issues have become apparent in the following two areas:

Annual nomination for the Board of Governors - Holding two different elections of Governors at different times with differing criteria and processes has been time consuming, confusing, complicated, costly and with no substantive benefits. In short, the current configuration has become outdated and difficult to justify under the governance model of the organization. Bylaw change is necessary to facilitate adjustment.

Establishing and Maintaining Regional Representatives and Committees – The role of Regional Representative has changed dramatically with the direct election of Governors by the Members. The role no longer has clear purpose and certainly is not a path to becoming a Governor. Regional Representatives, in fact, do not have any governance powers. The current role requires corresponding formation and management of a Regional Committee. In some areas, Regional Committees have not met as required by the bylaws. As with the role of Regional Representative, the purpose of the Regional Committee is in question. In addition to a lack of clear purpose, there have been issues in organizing, sustaining, and communicating with Regional Committees (whether from a Curl BC or from a Member Facility perspective). Again, bylaw change is necessary to clarify and properly establish operational alignment.

THE PROPOSAL

To address both the Zone-Regional adjustments and the Curl BC operational interface concerns relative to the regional areas – assuring best service to Member Facilities – the Board of Governors is recommending the following actions.

Proposed Changes

Geographical Areas

- The 11 Regions will now be 8 Zones
- Regional/Zone will now be Region
- No changes needed for Governor representation
- No changes needed for Competition

Board of Governors

- Clearly defined election process with required gender representation with all regions still represented
- Elections only held at the Meeting of the Members (Annual General Meeting)
- Clearly defined nomination process for all Governors
- Terms change from two to three years with a maximum of six consecutive years.
- More well defined and appropriate provisions for Removal of Governor, when necessary.

Regional Representatives

• Regional Representatives and committees discontinued and removed from Bylaws

Justification and other support information for the proposed changes

Geographical Areas

- No change on the boundaries for Governors, the five geographical areas do not change.
- Competition has been using the new geographical areas for some time. Provincial Youth events are now aligned.
- Curl BC boundaries will be aligned with most provincial sporting associations and other provincial youth events.
- No real changes to the geographical area.

Board of Governors

- Need to have gender equality.
- Clearly defined Nomination process and criteria for election.
- Governors represent all members and vote based on provincial matters.
- Continuation of ensuring that Governors are elected from all areas of the province (minimum one per regional area).

Regional Representatives

- With the use of video conferencing, Curl BC has the ability to communicate directly (and most effectively) with the Member Facilities. The role of the committee has been discussed for many years without any clear statement or justification for retention.
- This does not impede any Member Facilities or even Curl BC from holding group meetings to discuss local plans, events, or specific operational issues with area-wide implications.
