Q&A session

Question from Gordon Smith of the 100 Mile House Curling Club: Does the board know if government funding application have been approved, what programs are affected by grants not approved, and does the board have a plan to become less dependent on government funding?

Answer - Scott B.: It was known in February that the core grants would be funded; the main unknown was the gaming grant which has in fact been increased; and Curl BC has been encouraging philanthropy and grassroots fundraising as well as sponsor involvement

Question from Penny Shantz of Parksville Curling Club: Why the huge discrepancy in revenues and expenses, especially in Member Services?

Answer – Scott B.: Increase was due to additional and one-time government support; reduced receivables were a result of 15% of clubs staying closed during COVID and reduced competitors in championships.

Question from Colin Chan of the Vancouver Curling Club: Most money was spent on competitions instead of programs and services. Is this the best way to grow our sport?

Answer – Scott B.: It has been difficult to run in-person programming due to COVID-19, and much of the training went on-line resulting in lower costs. We expect this to pick up next year.

Question from Shaun Garvey of the Powell River Curling Cub: Could provincial sponsors be utilized at a local level?

Answer – Scott B.: Much of the sponsorship money does make it down to the local level, in the form of expanded programs from Curl BC. Also, clubs and their curlers can already receive direct benefits from several of the sponsors.

Question from Dale Cameron of the Marpole Curling Club: Could you explain the Member Services variance of \$302,906?

Answer – Scott B.: This was the auditor's way of accounting for the \$110,000 allocated for streaming, plus the 50/50 expenses.

Question from Christopher Jones of the Penticton Curling Club: Was the listed 50/50 amount of

\$133.500 the full total or half?

Answer – Scott B.: That was the full amount. We wound up with about \$50,000 after costs to support curling in Prince George.
