### 8. **Presentation of the 2022/23 Financial Statements**

• Q&A session:

**From Patrick Prade**: Are there government grants/funding that support Member Services rather than just Competitions?

**Scott**: Yes, but they're not necessarily restricted. We receive about \$200,000 yearly in core grant money and that allows us to provide staffing in the member services area, but generally grant money is sometimes targeted for specific things.

**From Patrick Prade**: No Administration for Long-Term Curler Dev? **Scott**: Staffing would be the answer there.

**From Colin Chan**: For Pillar Two, the bulk of funding comes from government but the bulk of expenditures goes to competitions rather than the delivery of programs and services. Is this focus on competition the best way to develop curlers long-term?

**Scott**: A lot of this money is hosting grants, and there have been significant increases in hosting grants as the government tries to stimulate the economy and stimulate a return to sport tourism and sport travel, and we hosted a major world championship. We expect this to continue for an organization like Curl BC which runs a lot of championships every year, so that's where a lot of this funding is directed.

**From Penny Shantz**: we had an entourage attend the Niagara Falls conference in the summer last year... can you share what happened there as I think it was a big expense?

**Scott**: The chair goes at the governance level, and I go at the operational level, and the idea is that it's an idea exchange and a very worthwhile expense. The sport is also advanced by the professional and personal relationships made there.

**From Jan Martens**: What are the guidelines for the restricted fund? What is the intention for the funds?

**Scott**: The definition of restricted funds is that it is given for a purpose. The auditors spend a lot of time in this area. They're very concerned with making sure the membership can see what funds were given for and where they were allocated

**From Penny Shantz**: I think Kimberly Dennis could also attend this conference! I think we had 6 people last year attend and I am not sure she was one of them... please include her as I think she is a Superstar!

Scott: We had three people attend last year and two this year, and I think it's worthwhile.

(It's a great program - all our junior coaches, volunteers or trainers, are required to take the SafeSport Course and have a CR check.)

**Scott**: Hi Chris. We have a full suite of Safe Sport policies on the Curl BC Website, I recommend you talk to Kim Dennis if you have any further questions.
